<b>Qualifications and/or experience</b>	<ul style="list-style-type: none"> <li>• Be registered, or be eligible for registration, as a Speech &amp; Language Therapist by the Speech &amp; Language Therapists Registration Board at CORU. <b>AND</b></li> <li>• Candidates must have the requisite knowledge and ability (including a high standard of suitability and professional ability) for the proper discharge of the duties of the office. <b>AND</b></li> <li>• Provide proof of Statutory Registration on the Speech &amp; Language Therapist Register maintained by the Speech &amp; Language Therapists Registration Board at CORU before a contract of employment can be issued</li> <li>• On appointment, practitioners must maintain annual registration on the Speech &amp; Language Therapists Register maintained by the Speech &amp; Language Therapists Registration Board at CORU.</li> <li>• Be eligible to work in the state.</li> <li>• Full manual drivers licence with access to own transport (applications from candidates with learner permit will be considered, with employment conditional upon securing full manual licence within 18 months of commencement).</li> </ul>	<ul style="list-style-type: none"> <li>• Clinical experience of working with children and their families as part of an interdisciplinary team with a pediatric FEDS caseload.</li> <li>• Relevant training specific to children with disabilities (0-18 years)</li> <li>• Demonstrates sufficient clinical skills in Speech and Language Therapy assessment, intervention and diagnostics to meet the specific needs of the relevant caseload 0 - 18 children's services.</li> </ul>
